- Budget 2021-2022 Morgan Smith
  - o Email to follow at later date regarding potential dates for budget committee meeting
  - o Committee to convene when we have a better idea of budget and what is allowed for fundraising opportunities for 2021/2022; likely rebuilding year.
  - o E-TEAM supported teacher appreciation week and gratitude gifts. Bought teachers shirts as a welcome gift upon return to in-class instruction.
  - o End of school year luncheon for teachers and staff to purchase total of 55 lunches
    - Subway lunch box (pre-boxed with 6" sandwich, cookie, chips) \$385; Costco sandwiches that will need to be individually boxed by us - \$270; Dominos can provide medium pizza for each person- \$330
    - Unanimous board vote for Subway. Will send out basic options to staff to choose their sandwich preference (forms will be printed out and placed in the office)
    - Coffee cart for teacher's appreciation was \$450. Of note, coffees were small from this vendor and they were late.
    - Previous years have used Domingo's
  - o Budget-wise, currently in good position due to hold on spending this year and modest spending previous years. However, if by Dec we can't raise \$160K, will dip into reserves for E-TEAM teacher salaries. Only 30% of families donated to annual giving.
